Pledges	<p>I hereby pledge that, with the financial aid granted hereunder, I will pursue my studies diligently in accordance with the provisions of the Ordinance Concerning Financial Aid Available from Shiga Prefecture and the Regulation for Enforcement of the Ordinance Concerning Financial Aid Available from Shiga Prefecture and the provisions set forth herein below, and that I will repay the financial aid granted hereunder in full by the specified date without fail.</p> <ol style="list-style-type: none"> In the case of failure to submit a bond for financial aid as set forth in Article 7, paragraph 1 of the Regulation for Enforcement of the Ordinance Concerning Financial Aid Available from Shiga Prefecture, I agree to not lodge a protest if I am demanded to repay the entire amount of financial aid granted hereunder in full in a lump sum. In the case of failure to repay the amount of financial aid granted hereunder in full by the due date, I agree to pay a default interest, the amount of which shall be calculated by multiplying the amount due by a 10.75% per annum interest rate according to the number of days elapsed from the day following the due date until the actual date of repayment. Financial aid for entry to a school is available exclusively for applications submitted in April by first-year student applicants. If you request financial aid for entry to a school, circle "Yes" in the corresponding column. After the last day of April of your first school year, any application shall not be acceptable. The base amount of financial aid for entry to a school is 50,000 yen, which equally applies to national or public schools and private schools. They may continue receiving financial aid until the final academic year in which the curriculum is completed in a senior high school or another educational establishment, provided that prescribed renewal formalities are completed for each academic year. Applications for financial aid for entrance fee are accepted only in April of the year when applicants are first-year entrants in a senior high school or another educational establishment.</p> <p>○ Discontinuation of financial aid</p> <p>Financial aid will be discontinued from the following month in any of the following cases:</p> <ul style="list-style-type: none"> The recipient no longer fulfills the requirements specified in Article 2 of the Ordinance Concerning Loans Financial Aid Available from Shiga Prefecture. The recipient declines financial aid. The recipient is found in a situation that is deemed inappropriate for a financial aid recipient. <p>○ Submission of a Bond for Financial Aid</p> <p>Financial aid recipients must submit to the Board of Education a bond for financial aid jointly signed with their cosigner indicating the entire amount of the financial aid, when the recipients graduate from a senior high school or the financial aid is discontinued. Recipients who fail to do this are required to repay the entire amount of the aid received thusly in full in a lump sum.</p> <p>○ Repayment schedule</p> <p>Financial aid must be repaid within a period not exceeding ten years starting from six months after the day of the recipient's graduation from senior high school or the termination of the financial aid, and in equal installments on a monthly, biannual or annual installments, according to the repayment schedule indicated in the signed bond for financial aid submitted by the recipient. The due dates are the last day of each month, the last days of July and November, and the last day of November of each year during the repayment period, respectively, for repayment on a monthly, biannual, and annual installments. The repayment may be made either through electronic transfer from the recipient's account or personal deposit at a banking institution.
